

I consent to Gesar Travel & more KG whom is acting as travel agent or tour operator (hereinafter referred to as “travel agent”) for trips to various third countries for which neither an adequacy decision as per Art 45 section 3 GDPR nor suitable guarantees as per Art 46 GDPR have been obtained (Art 49 Abs 1 GDPR), meaning they are not defined as third countries (see the list created on the deadline 01.03.2018 and presented to me),

conducting all data processing procedures which are required in order for the travel agent to make the bookings, invoicing and accompanying organisational measures required for my trip, in particular for the following purposes:

- o Bookings pertaining to travel, guides, hotels, restaurants, rental vehicles, transfers, registry, insurance, events, tours, accreditation and vouchers including customer systems, invoicing and checking thereof (B2B, B2C, FIT),
- o Booking tickets
- o Booking hotels

This includes the travel agent passing my data on to partner agencies, hotels, transport enterprises, insurances etc. as a service provider and/or responsible persons for their own processing, without which a booking could not be completed.

The declaration of consent includes the following personal data, particularly

- any master data (last name, first name, address, email address, telephone number),
- the data contained within travel documents (in particular passport number, passport data, date of birth, issuing authority, expiration date, biometric data, national heritage),
- data regarding payment type and pertaining to EC-cards, credit cards and bank cards,
- destinations, hotels, length of stay, contact persons, conditions, special services, medical data, frequent flyer number and
- medical data including medication e.g. in connection with allergies and illnesses of any kind, as well as data on special requirements and regarding marital-/ partnership

I was explicitly and extensively informed that,

- for this purpose, all this personal data must also be transferred to states outside of the EU so that the travel agent can either perform all required processing procedures or pass them on the third parties.
- these third countries do not fulfil the valid EU and Austrian data protection standards: There is no adequacy decision as per Art 45 GDPR and there is also no suitable guarantee as per Art 46 GDPR.
- the transfer of personal data is associated with a risk of the data in question being processed by unknown third parties, in violation of the current Austrian and EU data protection standards, and that my rights, as the individual concerned, cannot be guaranteed, the permissible processing and storage period could be exceeded and Gesar Travel & more KG cannot prevent this from happening.

Regardless, I accept all of the above and explicitly consent to data processing by and data transferring to the third countries named in appendix 1 and acknowledge that

- these measures are necessary for fulfilment of contract by the travel agent and are in my interest,
- all tours and all connected services, which I will book through the travel agent in future, should be executed as effectively and efficiently as possible, and that my particular customer wishes may continue to be considered moving forward and
- may be saved for 3 years after the longest statutory requirement to preserve records,
- so that this data may be used to create a new booking, as specified by myself, and
- can be passed on to third parties, to the extent necessary.

I was advised, that I am entitled to partially rescind or entirely revoke this declaration of consent at any time with respect to the travel agent.

I acknowledge that the data protection policies of the travel agent are published on their website www.gesar-travel.com/privacy-policy and hereby acknowledge that I have read, understood and agree with them.
